New Recruits Join RAA



Audit Impact Playbook Finalization Meeting





RAA hosts first D&D Workshop for joint IDI-ADB initiative for Sustainable Performance Audit Practices

The RAA hosted the first Design & Development (D&D) Workshop for Phase II of the joint initiative of the INTOSAI Development Initiative (IDI) and the Asian Development Bank (ADB) on "Sustainable Performance Audit Practices in Asia and the Pacific" in Thimphu from 22nd April to 3rd May 2024.



A global team of 20 resource persons from the participating Supreme Audit Institutions (SAIs) from Bangladesh, Bhutan, Mongolia, Nepal, Papua New Guinea, & the Philippines, along with the IDI and other INTOSAI bodies deliberated and developed content for key areas to lay a strong foundation for activities and inputs throughout the upcoming year for the initiative. It is aimed at raising the profile of performance auditing and paving the way for sustainable performance audit practices in the region.

This MoU will be valid for the period of five years from the date of signing.



The RAA participated in the recently concluded 'Leadership Forum' & 'Educational Workshops' which were conducted as part of Phase II of the joint Asian Development Bank and the INTOSAI Development Initiative on "Sustainable Performance Audit Practices in Asia and the Pacific" in Manila from 3rd to 14th June 2024. The Auditor General led a 3-member delegation to the 2-day Leadership Forum on 'Raising the Profile of Performance Audits' for Supreme Audit Institution (SAI) Leaders and Key Stakeholders on 3rd to 4th June 2024. The Leadership Forum's objective was to share reflections, experiences, and innovative ideas for tackling issues such as raising the profile for performance audits, developing competencies of performance auditors, systems for ensuring sustainability and quality of performance auditing, and planning for the impact of performance audits.

Prior to this event, the Auditor General attended the World Bank's Public Administration Global Forum – 'Transforming Governments for a Livable Planet' as a panelist and spoke on 'Strengthening Public Accountability and Integrity in Public Administrations' in Washington D.C., USA from 28th to 29th May 2024. Subsequently, three Performance Auditors of the RAA participated in two Educational Workshops i.e. 'Professional Education for Performance Auditors' from 5th to 7th June 2024 and 'Strategic and Annual Audit Planning' from 10th to 14th June 2024. The workshops aimed to:

- 1. Provide comprehensive learning for the team leaders from six SAIs on developing competency frameworks for performance auditing and on executing strategic and annual (performance) audit planning with a focus on impact.
- 2. Enhance the ability of resource persons to oversee the updating of relevant systems and refining the relevant processes within their respective SAIs. Two of the participants, Sonam Delma, AAG & Samdrup Delma, DCA are part of the global team of 20 resource persons for this initiative for enhancing sustainable Performance Audits in Asia and the Pacific.







Joint Sitting endorses PAC's recommendation to address recurring audit irregularities, HR issues

Considering the recurrence of similar irregularities every year in the Annual Audit Report, the Parliament's Public Accounts Committee recommended the government develop a strategy to address the issue. However, a few Members of the Parliament said that the committee should come up with a stringent measure or recommendation to hold people accountable.

The audit findings saw almost Nu. 3 billion worth of irregularities in the FY 2022-23. Of the total irregularities, almost Nu 40 million was categorized under 'Fraud and Corruption', more than Nu. 2 billion under 'Non-compliance to Laws, Rules and Regulations' and over Nu. 550 million under 'Shortfalls, Lapses and Deficiencies'. However, the committee found that the total irregularities decreased by over 60% as compared to FY 2021-22.

The committee noted that the nature of irregularities has become a pattern across agencies as they feature continuously in every audit report. FY 2022-23 noticed outstanding public work advances to be the major reason for irregularities followed by excess payment and wasteful expenditure among others. The Public Accounts Committee proposed three recommendations.

- 1. Need for the government to develop a strategy to address issues on public expenditure such as excess payment and spending without work being done.
- 2. Government to consult with the Civil Service Commission to review existing human resource gaps in public service delivery and ensure timely replacement in the 13th Five-Year Plan.

The Public Accounts Committee presented its Review Report of the RAA's Annual Audit Report 2022-2023 and the Follow-up on Review Reports of Annual Audit Reports 2010-2022 to the Joint Sitting of the Fourth Parliament on 2nd July 2024. The Chairperson of the Public Accounts Committee, Hon'ble Rapten, Phuentsho **Eminent** Member of the National Council, presented the certification of the Annual Financial Statements, irregularities by categories, resolved and unresolved irregularities by categories and agencies, and the observations Committee's recommendations in the joint sitting of the Parliament.





The Joint Sitting of the Fourth Parliament deliberated on the Public Accounts Committee's Review Report of the RAA's Annual Audit Report 2022-2023.





3. Need for the government to expedite the policy decision over the dam or barrage option for PHPA-I at the earliest with the relevant counterpart and ensure that the underground powerhouse and the erected electro-mechanical equipment do not pose challenges during the testing and commissioning time.

These recommendations are in addition to the seven recommendations recommended by the Royal Audit Authority.

However, some MPs said that with irregularities and recommendations remaining the same every year, there is a need to reform the system and find specific solutions.

"What I understand is that it is not like we need to have new rules, regulations and procedures but the issue here is non-compliance. So, what I suggest is to make these procedures stronger," said Younten Phuntsho, Agriculture and Livestock Minister.

The House endorsed all the recommendations made by the committee through a show of hands.

"Where we live must be clean, safe, organized, and beautiful, for national integrity, national pride, and for our bright future. This too is nation-building." His Majesty the King of Bhutan ~ April 2, 2015. The RAA Head Office, OAAGs and PDRC observed the Zero Waste Hour from 4 PM to 5 PM by cleaning respective offices and premises.




New Office Building for OAAG, Phuentsholing
